ffreehold property at Lymington in the County of Southampton or elsewhere in the Kingdom of England And also all leasehold Property I might be entitled to money and securities for money in England or elsewhere to which I am entitled under and by virtue of the last Will and Testament of Mr John Taylor late of Lymington deceased from and immediately after the decease of Mr Thomas Brice of Lymington aforesaid Gentleman unto my very good friend Mr George Sandey of the City of New Sarum Ironmonger for his care and attention to me and to heirs executors Administrators and Assigns for ever In trust nevertheless to fulfil the purposes of Deed entered into between him and me and bearing date on or about the twenty fourth day of ffebruary one thousand eight hundred and fifteen and after that is fulfilled I give and bequeath unto my Good friends for their care and attention to me as follows to Mrs Mary Woods of the City of New Sarum Widow the Sum of one hundred pounds of lawful money to Mr Walter Aslat of the said City the Sum of one hundred and twenty pounds to Mr Anthony Bradby of the said City the Sum of twenty pounds To Mr William Knight of the said City Stable Keeper the Sum of thirty pounds To Robert Woods of the said City Book Binder the Sum of ffifty pounds and to George Gurd of Coombe Bissett aforesaid the Sum of twenty pounds which legacies it is my Will be paid to the above persons their executors Admors and Assigns within one month after the said George Sandey his heirs Exors or Admors shall be in possession of the property to which I am entitled under and by virtue of the Will of the said John Taylor deceased the property under the Deed being first satisfied and paid as in the said deed is mentioned I also give unto Miss Downing at the Goat (?) the Sum of twenty pounds to be paid at the time before mentioned And all the rest residue and remainder of my property expectant and in remainder I give devise and bequeath unto the said George Sandey his heirs Exors and Admors for ever And I do hereby nominate constitute and appoint the said George Sandey sole Executor of this my last Will and Testament hereby revoking all others I do declare this to be my last In Witness whereof I have hereunto set my hand and Seal the twentieth day of April in the Year of our Lord one thousand eight hundred and fifteen Elizabeth Sparrow
