The Chairman, in opening the proceedings, spoke of the importance of meeting to provincial cyclists, and expressed pleasure at the large attendance of delegates. Mr. S. Young reported upon the

present position of the case "Hayman v. James," in which the local centre is supporting the plaintiff in a county court action for damages on the ground of having been rundown on the high road by defendant. Mr. F. W. Brock and Mr. W. J. Price reported the proceedings at the Birmingham Conference of Provisional Cyclists on the 3rd instant. The rest of the evening was occupied in considering the agenda of the council meeting to be held at London on the 6th proximo. The result was an unanimous decision to register proxy votes (to the number of 34) in favour of the propositions, standing in the name of the local centres, appointing a committee to reorganise the Union upon certain specific lines. The following were unanimously appointed as additional delegates to the London Council:- Mr. W. M. Appleton, chairman of the centre, and Mr. W. J. Price, honorary secretary , being ex officio members; Messrs. F. W. Brock, C. T. Coulsting, John Doggett, and C. Robbins. Proposed new rules and regulations in regard to racing were also considered. A vote of thanks was carried to the chairman for his management of the meeting.
