Mr. Churchill Presides over the Ceremony

The annual ceremony for nominating the sheriffs for the various counties of England and Wales took place yesterday afternoon in the Lord Chief Justices Court. Mr. Winston Churchill, as Chancellor of the Exchequer, presided, wearing the black and gold ceremonial robes of his high office. He was accompanied on the Bench by the Lord Chief Justice (Lord Hewart) and Justices Avery, Sankey, McCardle, Arton, Finlay and Mackinnon. Mrs. Churchill and other ladies were seated in the jury box. The Kings Remembrancer Sir Thomas Willes Chitty, read out the list of Sheriffs for last year, and when a vacancy occurred, the judges were in turn called upon to nominate a name for the vacancy. The excuses put forward by gentlemen who asked on various grounds to be relieved from serving were submitted by Sir Maurice Hankey, Secretary to the Privy Council, to the Chancellor and the judges for approval and were generally acceded to. Some gentlemen were excused by reason of want of means and others because they were over 70.
