Líttle Hínton 1800-1849

1832

Wilts County Sessions Thomas Drew, for stealing wearing apparel at Little Hinton – 6 months' hard labor. Devizes and Wiltshire Gazette 25 October 1832

1833

COMMITTED TO THE HOUSE OF CORRECTION, DEVIZES

Charles Pullen, for three months, for leaving his family chargeable to the parish of Little Hinton.

1835

Committed to House of Correction, Devizes. Pharoah Thorne and Daniel Jones, for leaving the service of Mr Henly, of Little Hinton. Devizes and Wiltshire Gazette, 3 September 1835

1836

COMMITTED TO THE HOUSE OF CORRECTION, DEVIZES Richard Warren, for one month, for leaving his family chargeable to the parish of Little Hinton. Devizes and Wiltshire Gazette 26 September 1833

1838

COMMITTED TO MARLBOROUGH BRIDEWELL Charles Pullen, for three months, for leaving his family chargeable to the parish of Little Hinton.

1839

COMMITTED TO MARLBOROUGH BRIDEWELL George Thorne, for two months, for leaving his family chargeable to the parish of Little Hinton.

1840

COMMITTED TO MARLBOROUGH BRIDEWEL Thomas Waite, for trial, stealing a shovel, at Little Hinton. Salisbury and Winchester Journal 29 June 1840

1841

COMMITTED TO MARLBOROUGH BRIDEWELL James Jakeman, for trial, charged with stealing a pair of shoes, the property of Henry Parrier [Purrier] at Little Hinton. Devizes and Wiltshire Gazette 13 May 1841

COMMITTED TO MARLBOROUGH BRIDEWELL Enos Collier, for trial, charged with stealing fowls, the property of David Sheppard, at Little Hinton.

COMMITTED TO THE NEW PRISON, DEVIZES Enos Warren for one month, for leaving the service of John Johnson at Little Hinton. Bath Chronicle and Weekly Gazette 12 October 1843

1845

ESTATES vested in ASSIGNEES Gazette, Aug. 26, 1845 Coster, Jacob, of Little Hinton, labourer – Fisherton Anger. Perry's Bankrupt Gazette 30 August 1845

1846

COMMITTED TO THE NEW PRISON, DEVIZES George Thomas, for 3 months, for leaving his family chargeable to the parish of Little Hinton.

Devizes and Wiltshire Gazette 8 October 1846

1848

COMMITTED TO THE NEW PRISON, DEVIZES Thomas Webb, for six weeks, for misconduct in the service of Farmer Johnson. To whom he as an apprentice as blacksmith at Little Hinton. **Wiltshire Independent 20 April 1848**

1849

Charles Pullen, for one month, for stealing a bushel of potatoes from the land of Thomas Arrowsmith, at Little Hinton. Bath Chronicle and Weekly Gazette 28 August 1849
