I Joseph Dyer in the Parish of Langbridge Deverell in the County of Wilts by the Mercy of God being of a sound mind do make this my last Will & Testament in manner following ffirst I do appoint my dear Wife Sarah Dyer my sole Executrix & that without any Interruption she shall enjoy during her natural life all my Goods & Property of every description some of which is in the four P Cent Stock that it is also my Will that after the decease of my Wife my Stock in the four P Cents shall be equally divided between my three Daughters Sarah Dyer Charlotte Baldwin & Rachel Dyer that it is also my Wish & Will that should my Daughter Charlotte Baldwin not survive her Mother that her share shall remain & be equally divided between her Children when they are of the Age of twenty one Years – that it is also my Will that my Dwelling House at

Crockerton after the death of my Wife shall be for the residence of my two Daughters Sarah & Rachael Dyer as long as they wish to continue the same & remain unmarried when sold the money to be equally divided between my three Daughters Sarah Dyer Charlotte Baldwin & Rachel Dyer but never to be sold without the mutual consent of my two Trustees That it is also my Will should any of my Daughters die & my dwelling House remains unsold that her or their shares shall be divided between or become the Property of the Surviving sister that it is also my Will that the whole of my Household Goods & ffurniture Plate etc. be equally divided between my Daughters Sarah & Rachael Dyer with the exception of one Silver Ladle & it is also my Will that my two Daughters Sarah & Rachel Dyer should partake of the benefit of any Interest arising from the Money I have invested in the four per Cent Stock (& which is to be regularly received by my dear Wife as long as she lives) so it is also my Will & I hereby Authorize my dear Wife Sarah Dyer to sell from my aforesaid Stock in the four P Cents one hundred pounds if she finds it necessary to pay all my just Demands but no more than one hundred pounds to be sold from my aforesaid Stock I do also appoint Mr Gregory Sale of Crockerton in the Parish of Sutton Veney in the County of Wilts & Nathaniel Everett of Cockerton in the Parish of Longbridge Deverell in the County of Wilts my Trustees to this my Will I do declare this to be my last Will & to which I have put my hand & Seal this 18th day of May in the year of our Lord 1812 *Joseph Dyer* Signed sealed & delivered in the presence of us *John Hiscutt _ Henry Baker*
