On which Day appeared personally Thomas Everatt and alleged That Thomas Coxe late of Oaksey in the County of Wilts Yeoman did in his life Time make and duly publish his last Will & Testament in Writing & thereof appointed Edward Coxe and William Phillimore joint Executors who duly proved the said Will

That the said Edward Coxe and William Phillimore are both since dead Intestate leaving certain Goods Rights and Credits of the said Thomas Coxe unadministered

That he the said Thomas Everatt is one of the nephews and next of Kin of the said William Phillimore deceased Wherefore he prayed that Administration of All and Singular the Goods Chattels Rights & Credits of the said Thomas Coxe unadministered as afore might be granted and Committed to him on giving such good and sufficient Security as in that Behalf is required and so for

Let Administration of the Goods unadministered as aforesaid be granted as above prayed

Know all Men Presents, That We Thomas Everatt of the parish of Cam in the County of Gloucester Butcher And William Harper of the parish of Cam aforesaid Scribler are held, and firmly bound unto William Lord Bishop of the Diocese of Gloucester in Five Hundred pounds of good and lawful Money of Great Britain, to be paid unto the said Lord Bishop or to his certain Attorney, his Executors, Administrators, or Assigns. To which Payment, well and truly to be made, We oblige ourselves, and Each of us by himself, and Themselves for the whole, our and Each & every of our Heirs, Executors, and Administrators, firmly by these Presents. Sealed with our Seals. Dated the Sixth Day of September in the second Year of the Reign of our Sovereign Lord George the Third by the Grace of God, of Great Britain, France, and Ireland, King, Defender of the Faith, and so forth, and in the Year of our Lord One Thousand Seven Hundred and Sixty Two.

The Condition of this Obligation is such. That if the above bounden Thomas Everatt Administrator of all and singular the Goods, Chattels and Credits of Thomas Cox Deceased, late of Oaksey in the County of Wilts Yeoman unadministered by Edw. Coxe & William Phillimore, do make, or cause to be made, a true and perfect Inventory of all and singular the Goods, Chattels, and Credits of the said Deceased, which have or shall come to the Hands, Possession, or Knowledge of him the said Thomas Everatt or into the Hands and Possession of any Person or Persons for him and the same, so made, do exhibit, or cause to be exhibited, into the Registry of the Lord Bishop of Gloucester at or before the Last Day of October next ensuing, and the same Goods, Chattels, and Credits, and all other the Goods, Chattels and Credits of the said Deceased, at the Time of his Death, which at any Time after shall come to the Hands or Possession of the said Thomas Everatt or unto the Hands and Possession of any other Person or Persons for him do well and truly administer according to Law; and further, do make, or cause to be made, a true and just Accompt of his said Administration at or before the Last Day of September 1763 and all the Rest and Residue of the said Goods, Chattels, and Credits, which shall be found remaining upon the said Administrator's Accompt, the same being first examined and allowed of, by the Judge or Judges, for the Time being, of the said Court, shall deliver and pay unto such Person or Persons respectively, as the said Judge or Judges, by his or their Decree or Sentence, pursuant to the true Intent and Meaning of a late Act of Parliament, made in the Two and Twentieth and Three and Twentieth Years of the Reign of our late Sovereign Lord King Charles the second, intitled. An Act for the better settling of Intestate's Estates, shall limit and appoint: and if it shall hereafter appear, that any last Will and Testament was made by the said Deceased, and the Executor or Executors therein-named do exhibit the same into the said Court, making Request to have it allowed and approved accordingly, if the said Thomas Everatt above bounden, being thereunto acquired, do render and deliver the said Letters of Administration (Approbation of such Testament being first had and made) in the said Court, then this Obligation to be void, or else to remain in full Force and Virtue.
