This is the last Will and Testament of me Elizabeth Osmond of Ramsbury in the County of Wilts Widow Whereby I direct my Executors hereinafter named to pay and discharge all my just debts funeral and Testamentary Expences I give and bequeath unto each of my Sons Richard Osmond John Osmond Thomas Osmond William Osmond and Stephen Osmond a legacy or Sum of One hundred and fifty pounds which I direct to be paid to them respectively within twelve months after my decease I give and bequeath unto each of my daughters Elizabeth Wise Sarah Wickham Anne Richens Hannah Osmond and Mary Osmond a legacy or sum of four hundred pounds to be also paid within twelve months after my

decease Provided always and I do hereby direct that in case a Sum of one thousand pounds advanced by me to my Son Thomas on Bond or any part thereof shall remain due and owing from my said Son at the time of my decease my said Executors shall allow him the space of five years from my decease for paying the same he paying in the mean time interest at the rate of five pounds Per Cent Per Annum on the amount due from him and then and in that case the said sum of One thousand pounds or so much thereof as shall remain unpaid shall in case my other Assets shall be insufficient to pay the several legacies hereinbefore bequeathed be deducted and kept back out of the said several legacies in due proportions and the deduction or deficiency shall be paid and made good to the said legatees respectively when and as the said Thomas Osmond shall pay off and discharge the said debt and interest or such part thereof as shall be due and owing from him and in the mean time the said legatees shall be entitled to receive the interest payable by the said Thomas Osmond in proportion to the amounts due to them respectively And as to all the rest residue and remainder of my ready money monies in the funds debts securities debts and securities for money and all other my personal Estate and Effects whatsoever I give and bequeath the same and every part thereof unto and equally between all and every of my Sons and Daughters share and share alike as tenants in Common and not as joint Tenants Provided also And I hereby declare that in case either of my said Sons or Daughters shall depart this life in my lifetime leaving lawful Issue then the legacy hereinbefore bequeathed to such Son or Daughter respectively so dying as aforesaid and also his or her share of my residuary estate shall go and be paid to such issue or such of them being Sons as shall attain the age of twenty one years or being Daughters shall attain that age or marry in equal share and proportions and the interest dividends and Annual produce shall in the mean time be applied and disposed of in and towards the maintenance and education of all the issue for the time being of either my said Sons or Daughters so dying as aforesaid And I do hereby nominate constitute and appoint my Sons the said Richard Osmond John Osmond and Thomas Osmond joint Executors of this my Will and hereby revoking all former and other Wills by me at any time heretofore made I do declare this only to be and contain my only true last Will and Testament In Witness whereof I the said Testatrix have to this my Will contained in two sheets of paper set and subscribed my hand and seal this fifth day of June one thousand eight hundred and twenty seven Elizabeth Osmond
