- 1900 William BUNCE and Thomas ILES, labourers, of Stratton, fined for not sending children to school. Citizen 23-02-1900.
 - -Ernest PANTING, baker, of Stratton, fined for driving with no lights. Citizen 23-02-1900.
 - -Emily BREAKSPEARE, servant of Stratton, stealing £11 from John LOVERIDGE, of Stratton on September 5th. Three months prison. Citizen 04-04-1890.

 - -Enos William TARRANT, a labourer of Stratton for being drunk & disorderly at 3:30 this morning. Agreed to go to Workhouse. *Swindon Advertiser 27-12-1901*.
- -Frederick BLUNSDEN, 14 of Stratton, for stealing a pack of cards and 1d from William H DAY, of Stratton Reading Rooms on Jan 5th. Bound over. *Swindon Advertiser 10-01-1902.*
 - -George RUSSELL, dealer of Stratton, for allowing 2 horses to stray on highway at Stanton.

Fined 1s each plus costs. Swindon Advertiser 24-01-1901.

 - -John MATTHEWS, carter of Stratton for not having control of horse & cart at Shrivenham on 16th Feb. Given 16 days in gaol. *Swindon Advertiser 13-03-1903*.
 - -Edwin PONTIN, 49, labourer, for stealing a pair of gloves, value 2s 6d, the property of Thomas PEARCE, of Stratton. On 27th January. Six months imprisonment. *Citizen 09-04-1903*.
 - -Cyclist in trouble Benjamin Austin, labourer of Lower Stratton for dangerous cycling 1s plus costs, and Edward Attwood of Swindon for riding on pavement in Cricklade Road, 3s 6d. also John Smith of Kingsdown for obstructing Regent Street with a cart fined 5s. Swindon Advertiser 10-04-1903.

 - -William BUTCHER, James REEVES, Charles COOK, James WORTH, Frederick HOLDMAN, William BEAMES & Arthur REEVES. Obstruction, Fined 1s each *Swindon Advertiser 05-05-1905*
 - Henry APLIN No light Proved Swindon Advertiser 05-05-1905
 - -David ILES of Upper Stratton for being in arrears of £1 10s, Order issued, also Walter LEGG & James SIMS of Stratton for breach of the peace outside Bakers Arms. Bond over on £1 plus 4s 9d each costs. Swindon Advertiser 26-05-1905.
 - -George PULLEN Enos LAWRENCE & William JOHNSON all of Stratton were summoned for not sending their children regularly to school. Fined 5s each. *Swindon Advertiser 09-06-1905*.
 - -Jesse BOWLEY, of Stratton for riding a cycle without a light at 1:30 a.m. Citizen 16-06-1905
 - -Sarah RICHENS, married woman of Stratton, for assaulting a youth Walter George MAPSON on 8th July. Bound over for £2 and 8s costs. *Swindon Advertiser 14-07-1905.*
 - -William MOESE labourer of the Green for using obscene language. Fined 3s & 7s costs. Also, Joseph RICHENS, labourer of Upper Stratton for similar offence, 4s 6d costs. *Swindon Advertiser 14-07-1905*.
 - -Ralph TITCOMBE, of Stratton for being drunk & disorderly. Costs 4s. also, Harvey PULLEN 4s costs and bound over for 3 months. *Swindon Advertiser 04-08-1905*.
 - -John FERRIS, of Stratton summoned for maintenance arrears of £1 17s 6d. Order made. *Swindon Advertiser 28-07-1905.*
 - -Catherine JAMES, tramp for begging in Stratton & using obscene language. 7 day in each

- case, concurrently. Swindon Advertiser 11-08-1905.
- -William WEEKS, of Stratton, was summoned by Hannah GASKIN, a gipsy, for assault on August 13th. Case dismissed and FASKIN ordered to pay costs 4s 6d. *Citizen 22-08-1905*.
- -James MOORE of Stratton for stealing the property of Mr. GILBERT of Stratton. Sentenced to 14 days. *Citizen 22-08-1905*.
- -William WEEKS of Stratton was summoned by Hannah GASKIN, a gypsy, for assault. Dismissed, Gaskin to pay costs 4s 6d. *Swindon Advertiser 25-08-1905*.
- -Frederick BARRETT of Stratton for stealing 3d worth of mushrooms the property of Mr J K Coleing of Highworth. Fined 5s plus 7s costs and 3d damages. *Swindon Advertiser* 15-09-1905
- -Richard POWELL and Thomas CURNICK both of Stratton summoned by RSPCA for cruelly treating a horse. Fined £1 5s. Swindon Advertiser 15-09-1905.
- -William Albert SIMS, Richard SILK, H. PULLEN, of Stratton, were fined 6s 6d, and Ernest PULLEN, John ARKELL, Henry WILSON, James TAYLOR, and Albert MOULDING, 4s each for playing Banker in a public place on September 17th. *Citizen 03-10-1905*.
- -John Fisher LOOKER, of Stratton applied for separation from his drunken wife, Louise A. LOOKER. Order granted, husband to get custody of children and pay wife 6s per week. *Citizen 27-10-1905*.
- -Levi MILLARD, of Stratton, was summoned by Alfred JACKSON for stealing 1s on October 24th. Fined £5 or 28 days. *Citizen 27-10-1902*.
- 1906 Ralph WRIGHT 21, and Frederick BLUNSDON both labourers of Stratton were indicted for breaking into the house of Thomas LOVE, baker of High Street, Stratton on 21st March. Bailed at £10 each Swindon Advertiser 30-03-1906. At Quarter Sessions, Wright pleaded guilty but Blunsdon denied the offence. Both given 4 months' hard labour. Swindon Advertiser 06-04-1906.
 - Henry ILES of Stratton for bad language in argument over sale of strip of land. Fined 2s 6d & 7s costs. Also, George ISLES on similar offence after a collision with a Tram in Gorse Hill. Fined 1s and 10s costs. *Swindon Advertiser 18-05-1906.*
 - -Henry Brown ANDREWS,22, labourer, guilty of setting fire to a farm building at Stratton. Four months hard labour. *The Bath Chronical 18-01-1906.* Committed to County Assizes *Swindon Advertiser 25-05-1906.*
 - -Walter Henry JUKES, 47, farmer, and assistant overseer, of Stratton charged with setting fire to Pidgeon House farm on Tuesday 13th March. Put on remand. *Citizen 16-3-1906*. Bail was set at £1,500 *Citizen 20-3-1906*. He was also later charged with embezzling £14 17s paid to him as rates from Mr. Henry Charles LOOKER on May 1906, and also the Overseer's accounts were missing some £700. Bail refused and sent to cells for further evidence. *Citizen 11-05-1906*. New charge of receiving monies under false pretences from Joseph RUSSELL, for £100, £5 and £100 against parts of the farm. *Citizen 15-05-1906*. At Wilts Assizes he was finally charged with embezzling three sums of money amounting to £590 16s 6d, and with the charge of arson, the fire brigade found four separate locations for the fire starting, including one in the barn that housed the Stratton fire engine. It is believed the fire was set to destroy the Rate books. Given ten years for the arson and five years for the embezzling, to run concurrently. *Citizen 09-06-1906*. He was declared Bankrupt in July. *Western Gazette 05-06-1907*. Was in Portland Gaol when his Bankruptcy case was heard and was still saying he was innocent of Arson & Embezzlement. *Citizen 05-10-1907*.
 - -Frederick Charles BRUNSDON and Ralph WRIGHT, labourers, of Stratton were committed to Quarter Sessions on charge of housebreaking on 21st. Bail allowed. Citizen *27-03-1906* Sentenced 4 months hard labour. *Faringdon Advertiser 07-04-1906*.
 - -Alfred William Boodle, solicitor of Swindon charged with assaulting a girl under 16, Florence JORDAN, 14, daughter of Edwin Thomas JORDAN, GWR labourer of Stratton, had left school at end of October and gone into service with Mr. Boodle, on June 6th, 7th and 11th he assaulted her while she was cleaning the bedroom. He tried again on 14th, but she resisted and got away. She had not said anything until 17th as she was scared due to Mr Boodle's position. Adjourned, defendant on £100 bail. *Citizen 26-06-*

Accused was taken to a spot beside the road and in a ditch, there was the body, the neck was broken in two places, with a necktie as ligature about her neck, she had also been interfered with. The girl's mother from Elm Farm, Wanborough said she though he was only a friend of her daughter. A Doctor had described him as depressive with paranoiac tendencies.
