

THE SWINDON BOROUGH COUNCIL (ERMIN STREET) (WEIGHT RESTRICTION)
ORDER 2013

SWINDON BOROUGH COUNCIL and WILTSHIRE COUNCIL ("The Councils") in exercise of their powers under Sections 1, 2, 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The Borough of Thamesdown (Ermin Street, Stratton St Margaret) (Prohibition of Commercial Vehicles of Over 3 tons) Order 1979 is hereby revoked.
2. Save as provided in Article 3 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any heavy commercial vehicle in excess of 7.5 tonnes maximum gross weight to proceed along the length of roads specified in the Schedule to this Order.
3. Nothing in Article 1 of this Order shall make it unlawful for any person to cause or permit a heavy commercial vehicle to proceed along the length of roads referred to in Article 1 (hereinafter referred to as "the roads") if the said vehicle is being used:-
 - (a) for or in connection with the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the roads specified in the schedule.
 - (b) in connection with any building operation or demolition in or adjacent to the roads or the removal of any obstruction to traffic in the roads,
 - (c) in connection with the maintenance, improvement, or reconstruction of the roads,
 - (d) in connection with the laying, erection, or alteration or repair in or adjacent to the roads of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
 - (e) in the service of the Council in pursuance of their statutory powers or duties;
 - (f) for police, ambulance or fire service purposes in a case of emergency.

4. This Order shall come into operation on the 7 October 2013 and may be cited as The Swindon Borough of Council (Ermin Street) (Weight Restriction) Order 2013

SCHEDULE

Lengths of roads

Prohibition of heavy goods vehicles exceeding 7.5 tonnes maximum gross Weight

1. Ermin Street from the junction of the Oxford Road White Hart Roundabout to the junction with Swindon Road
2. Grange Drive from the junction with Swindon Road to the junction with Ermin Street
3. Swindon Road from the junction with Hobley Drive to the junction with Ermin Street
