Complainant asked her several times to close it. Prisoner refused to do so, and used bad language, on which she threatened to report her to Mr. Pritchard. Prisoner, using very bad language, said she did not care. On the complainant getting out of bed to close the window herself prisoner kicked her violently in her stomach with her nailed boots, causing her great pain. The complainants statement was corroborated by Fanny ADAMS and Harriett ROWLEY, two other inmates, but the prisoner denied that she kicked at all. She only pushed complainant with her shoe on the bed.

Messrs Chivers and Prior, banjoists, &c, and their services were much appreciated by all. Mr F. Garrett sang several good comic songs, to the thorough amusement of the inmates. Gifts were presented to every inmate, and consisted of pipes, tobacco, snuff, apples, biscuits, sweets and a sixpence each in money. After tea had been served, games, racing, &c, commenced and lasted till nearly dark. Messrs Chivers and Prior causing roars of laughter and fun, with their funny songs and antics during the evening. Through the thoughtfulness of Miss House, one of the guardians, some of the girls who are about leaving the institution for service, were given useful presents such as workboxes, &c. Hearty cheers were given to the Swindon friends who kindly contributed to the funds. The Rev. Mr & Mrs Scott, Miss Muir and others graced the company by their presence.
