The Minister reported that, as according to the By law of the church no. 2 any believer should be allowed to sit down with us residing in this town or neighbourhood, being members of other churches. Elizabeth Speckman's time was expired and not being able as yet to determine whether her residence in this neighbourhood would be short or long & yet desirous to communicate with us, it was resolved that under

Her peculiar circumstances, she should be allowed 6 months longer with the understanding that after that time it could not again be renewed.

Christ & their conscientious regard to what may be brought forward, called upon the Deacons to state the result of their inquiries. When it appeared, that, two charges being brought against Mary (Jon) Hollich that of swearing, & of taking up a hatches to strike the Constable, who, on a recent occasion, with others, came into her house, to claim goods, said to belong to another person the first thereof was witnessed by one young woman, but this charge, upon My Hollich being heard, was dropped.; the second charge being substantiated by at least two credible witnesses, she (M H) positively denied, & at last left the chapel in a prassion.

It was then put to the church whether any member, conducting herself in such a manner should be continued a member, especially after having been spoken to on two former occasions, according to our Lord's words Matthew 18/15-17. it was resolved that Mary (Jonⁿ) Hollich, should henceforth be no longer considered as a member of this church praying the Lord to keep each of the members by his power.

Thomas Gleed, As it has been thought necessary to bring the circumstances, which caused you to be dismissed from the Wharf, before the church of which you stand as member, it is right in me to give you notice that to morrow evening, being tuesday.

At the meeting Thomas Gleed was not present. Brother Horn stated the acts of dishonesty and mistrust of which Gleed had been guilty, upon the most undeniable & convincing proofs, it was unanimously resolved that Thomas Gleed be no longer a member of this Christian church recommending him in prayer to the mercy of God.
