FEET OF FINES 1377-1509

The Purpose of a Fine.

To add strength and security to a conveyance that had already been virtually effected was then the prime motive for making or, as it was called, 'levying' a fine. This is shown by two Wiltshire examples. On I7 May I287 Edward I granted by letters patent to Matthew son of John, knight, among other things the castle and manor of Devizes for life. In Michaelmas term in the same year Matthew acquired by fine the same estate from the king and Eleanor the queen?

Quin. Of Easter (1) Richard Beckote and Alice his wife, plaintiffs; Peter Courtenay, knight, and Margaret his wife, deforciants. Half the manor of Corhampton (Cornhampton), and of 2 messuages, 1 carucate and 1 virgate and 5 marks rent in South Tidworth (Suthtudeworth) and Warnford (Warneford), Hants, and 5shillings rent in North Tidworth (Northtudeworth), Wilts. Grant and render to plaintiffs. To hold to plaintiffs. (Warranty) Consideration. £20.

Oct. of Purification. (2) John Wakeryiig, clerk, William Hankeforde, knight, Master Adam Moteroii, canon of Salisbury, and John Rome, Henry Malpas, William Werkman and John Brok, clerks, plaintiffs; John Chitterne, clerk, deforciants Manors of North Tidworth (Northtudeworth), Littleton Pannell (Lytulton Paynel), and 26 messuages, 5 carucates, 20 acres meadow and 100 shillings rent in Chitterne, Bathampton (Battamton), Tilshead (Tydulsyde), Chicklade (Chiklade), Salisbury, Coate (Cotes) and Bishops Cannings (Canynges Bishop's) with a third part of the manor of Beamys (Beauinys), Wilts, and 1 messuage, 1 carucate, 12 acres meadow and 100 acres pasture in Henstridge (Hengstrugge) and Syles (Selesmerssh), Som, and the manor of Tangley (Tangele), 1 mill, 12 acres of land and 15 acres pasture in Houghton (Hoghton), Horsebridge (Hosebrugge) and King's Soniborne (Somborne), Hants. Right of John Brok. Render to pl. To hold to plaintiffs. (Warranty.) Consideration 400 Marks.

1423

Three weeks from Easter (3) Robert Warmwell and William Lorde, plaintiffs; Richard Etton of Salisbury and Joan his wife, deforciants. Twenty-one messuages, 204 acres of land, 100 acres pasture and 5 marks 16 shillings and 8 pence rent in Salisbury, Old Sarum, North Tidworth (Northtodeworth) and Ludgershall (Ludgarshale). Right of Robert, plaintiff's by gift of deforciant. Grant back and render to deforciant to hold during the life of Joan of 20 messuages, 4 acres of land and 5 marks 12 shillings and 8 pence rent in Salisbury and Old Sarum. Also grant to deforciant of 1 messuage, 200 acres of land, 100 acres. pasture and 4 shillings rent in North Tidworth and Ludgershall to hold during lives of deforciant. Successive remainders to William Ludelowe and Margaret his wife and the heirs of their bodies and the right heirs of Joan.

Morrow of Martinmas (4). William Gerard, parson of South Tidworth (Southtodeworth) and John Deverell, plaintiffs; William Alisaundre and Edith his wife, and Robert Peny and Joan his wife, deforciants. Three messuages, 3 tofts, 1 dovecot, 255 acres of land, 5 acres meadow, 400 acres pasture, 30 acres wood and rents of 20shillings and 2 roses in South Tidworth and Shipton Bellinger (Shepton Benger), Hants, and 5shillings rent in North Tidworth (Northtodeworth), Wilts. Right of William Gerard, plaintiff's by gift of deforciants. Grant back and render to William Alisaundre of I messuage and 15 acres of land in Shipton Bellinger. To hold to him. Also grant back and render to William Alisaundre and Edith of the other tenements to hold to them during their lives with remainder to Robert Peny and Joan and the heirs of Joan.

18 Henry VI 1439

Oct. of Michaelmas. (5) (Made quin. Of Trinity 17 Henry VI) (6). John Rowedon, clerk, and Robert Colpays, plaintiffs; William Chaumberleyn and Joan his wife, deforciants. Manor of South Tidworth (Southtodeworth), and 20 messuages, 6 tofts, 2 dovecots, 286 acres of land, 10 acres meadow, 400 acres pasture, 30 acres wood and rents of 20shillings and 2 roses in South Tidworth, Winchester (Wynton), Southampton (Suthampton), Littleton (Lytelton), Sparkford (Sparkeford) and Chilcombe (Chiltecombe) and the advowson of South Tidworth, Hants, and 5s. rent in North Tidworth (Northtodeworth), Wilts. Right of Robert, pl.'s having the manor, 18 messuages, 3 toftshillings 1 dovecot, 46 acres of land, 5 acres meadow and the advowson by gift of deforciants; remise and quitclaim to plaintiffs. (Warranty.) Grant back and render to deforciants To hold to deforciants and the heirs male of their bodies. Also grant to deforciants of reversion of 2 messuages, 3 tofts, 1 dovecot, 240 acres of land and 5 acres meadow, the pasture, wood and rents, which William Alisaundre and Edith his wife hold for the term of their lives in South Tidworth and North Tidworth of the inheritance of Robert. To hold to deforciants and the heirs male of their bodies. Successive remainders of the manor, 2 messuages, 3 tofts, I dovecot, 240 acres of land, 5 acres meadow, the pasture, wood and rent to the heirs of Joan and the right heirs of William, and of 18 messuages, 3 tofts, 1 dovecot, 46 acres of land and 5 acres meadow to the heirs of the body of William and his right heirs.

Quin. of Hilary (7) John son of John Wydeslade, and William son of Robert Estecote of Bidford (Bydeford), plaintiffs; John Wynard, esquire, and Elizabeth his wife, deforciants. Manors of Rolleston (Rolvyston), Cholderton (Chaldryngton), Charlton (Cherelton), Crawlboys (Croylboys) and the bailiwick and the keepership of the chase of Collingbourne Ducis (Colyngborne Ducis), and 16 messuages, 13 virgates, 20 acres meadow, 20 acres wood and 5 marks 6s. 8d. rent in Hilcott (Hyllecote), Wilsford (Wyllysford), Manningford (Manyngford), Manningford Bohun (Manyngford Wyke), Netheravon (Netherhaven), Collingbourne Ducis, North Tidworth (Northtudeworth), Ludgershall (Ludgarsale) and Biddestone (Budesden) and the advowson of Cholderton. Wilts, and the manors of Sutton Scotney (Sutton Scoteney) and Shoddesden (Shotesden) and 1 messuage, 1 virgate, 12 acres meadow, 20 acres wood, 1 yard of eels and 2shillings and 9 pence in rents in Romsey and Hordle (Hordwell), Hants. Right of John, plaintiffs' by gift of deforciants. remise and quitclaim to pl. (Warranty against George abbot of Westminster and his successors.) Consideration. £400.

- 1. In 1399 Easter Day was 30th Mrch so Quin (5) of Easter was 3 April
- 2. 1408/9 The Oct (8th) of Purification (of the Virgin Mary) was 9th Feb.
- 3. In 1423 Easter Day was 4th April.
- 4. Martinmas is 11 Nov so the Morrow of Martinmas is 12th Nov.
- 5. Michaelmas is 29 Sep so Oct (8th) of Michaelmas is 6th October.
- 6. In 1439 Trinity Sunday was 31st May so Quin (5) Trinity was 4th June.
- 7. Quin (5th) of Hilary (13th Jan) was 17th Jan.
