<sup>3</sup> British History Online states that the presentation of the Earl of Warwick's nominee may have been disputed by Sir Adam de la Forde but that this was ultimately unsuccessful.

<sup>4</sup> The Earl of Warwick died in 1401 and, as his heir was a minor, presentation would have been made by the Crown (Henry IV) if this occurred after the death of the Earl. Source: British History Online.

<sup>6</sup> British History Online notes that Thomas Spratt was forcibly removed from the Parsonage, allegedly for immorality and for keeping seditious books. It is unclear whether this resulted in him being unable to continue his duties as Rector.

<sup>7</sup> Name not recorded on commemorative plaque in Parish Church. Details noted from Burial Register for Woodborough, which records John Longe as “rector of this parish”.

<sup>8</sup> Commemorative plaque in Parish Church (St. Mary Magdalene) states 1592 as year of appointment. Reference to appointment date of 15 February 1583 from Clergy of Church of England database.

<sup>9</sup> Name not recorded on commemorative plaque in Parish Church. Details noted from Clergy of Church of England database and Parish Registers.

<sup>10</sup> The British History online website for Woodborough records that Francis Bayly was first presented in 1638. However, the Parish Burial Register records the burial of the previous incumbent (Adam Noyes) in 1652, with the note that he had been Rector for 54 years. Nevertheless, it seems likely that Francis Bayly succeeded Adam Noyes, albeit briefly before being ejected.

<sup>11</sup> During the period of the Commonwealth, Rectors were presented under the Great Seal and by the Lord Protector. Source: British History Online.

<sup>13</sup> The Commemorative plaque and Clergy of Church of England database record that Francis Bayly was reinstated in 1660, although British History Online states that Isaac Chauncey was not ejected until 1662. However, Isaac Chauncey had petitioned the House of Lords in 1660 to prevent Francis Bayly from collecting the tithes, so it would appear that the latter was acting as Rector, even if not formally reinstated.

**OPC Note:** Although the Clergy of the Church of England database records that George Wyld was appointed Rector of Woodborough on 20th May 1814 and resigned on 25th February 1835, it appears that he was never resident, or took a service, in Woodborough. Entries in the Parish register make it clear that all ceremonies conducted between 1816 and 1835 were carried out by a stipendiary curate, who was also living at the Rectory. During the period between 1816 and June 1829 Thomas Gale was the resident curate. The date of his quitting the Rectory in Woodborough is known, as an auction of his effects was advertised in the Devizes and Wiltshire Gazette. During the period 1829 to 1835 the resident curates taking all services were William Bleeck and Jasper Peck. William Bleeck also took up residence in the Rectory, where it is known he provided private tuition to at least eight children. George Wyld, who was almost certainly the father of Thomas William Wyld who took up the post of Rector in 1835, appears to have been resident in Speen (near Newbury), occupying the position of Vicar of Chieveley and private chaplain to Anne, Dowager Baroness Rodney the value of living being £800 per annum (the value of the living at Woodborough was £450 per annum).
