This is the last Will and Testament of me James Harrison of Wootton Bassett in the County of Wiltshire Silversmith and Joeller (?) made this eleventh day of ffebruary in the Year of our Lord one thousand eight hundred and twenty six first I give and devise unto Rebecca Harrison otherwise Rebecca Hurst who has resided with me upwards of forty years all that my ffreehold Messuage or Tenement Garden Hereditaments and Premises with the Appurtenances thereto belonging at Wootton Bassett aforesaid and now in my own occupation and also my Pew situate in the Chancel of the Church at Wootton Bassett aforesaid to hold to her the said Rebecca Harrison otherwise Hurst and her assigns for and during the term of her natural life and from and immediately after her decease then I give and devise the same and every part thereof unto my Nephew John Harrison Son of my late Brother John Harrison his heirs and assigns for ever I give and

bequeath to Mary Ann Hurst Granddaughter of her the said Rebecca Harrison otherwise Hurst the sum of ten pounds of lawful money Current in Great Britain I give and bequeath unto John Ladd of Calne in the County of Wilts and Samuel Dash of Wootton Bassett aforesaid Baker the sum of ten pounds apiece of like money all the rest residue and remainder of my Estate and effects money and Securities for money and all other my Estate and Effects whatsoever and wheresoever I give and bequeath the same and every part thereof after payment of my just debts the aforesaid several legacies my ffuneral expences and the costs of proving this my Will to the said Rebecca Harrison otherwise Hurst her executors administrators and assigns for ever and I do hereby nominate constitute and appoint the said John Ladd and Samuel Dash joint Executors of this my Will and revoking all former and other Wills at any time heretofore made I do declare this only to be my last Will and Testament In Witness whereof I have to this my last Will and Testament set my hand and seal the day and Year first above written \_ the mark and seal of James Harrison
