This is the last Will and Testament of me Joshua Gerrard Mead of Warminster in the County of Wilts Yeoman which hereby revoking all former and other wills by me at any time heretofore made I do make publish and declare in manner following that is to say I give and bequeath unto my dear Wife Phillis Mead all that my dwellinghouse with the garden thereto belonging and adjoining being part of a leasehold Estate held by me under the most Honorable Marquis of Bath called late Benjamin Pa..... situate lying and being at Crockerton in the said County of Wilts To hold to her my said Wife

and her assigns for and during the term of her natural life if the Estate and Interest I have shall so long continue And from and immediately after my said Wife's decease I give and bequeath the said dwelling house and garden unto my son David Mead his heirs executors administrators and assigns for all such Estate and Interest as may be therein yet to come I give and bequeath unto my said Son David Mead All the remaining part of the said Leasehold Estate not hereinbefore given and bequeathed to my said Wife To hold unto the said David Mead his heirs executors administrators and assigns for all such Estate and Interest as may be unexpired at the time of my decease I give and bequeath unto the said David Mead the sum of one hundred pounds to which I am entitled under the Will of my late Brother John Mead late of Hornblotton in the County of Somerset deceased after the death of his Widow Mary Mead I also give and bequeath unto my said Son David Mead all sum and sums of money and all benefit and advantage to which I am entitled as a legatee under the Will of my brother Samuel Mead late of South Brewham in the County of Somerset Yeoman deceased subject to the life interest therein of his Widow Mary Mead To hold unto the said David Mead his executors admors and assigns to and for his own absolute use and benefit But in case my said Son David Mead shall depart this life unmarried and without lawful issue before the said monies and premises to which I am entitled under the respective wills of the said John Mead and Samuel Mead shall respectively become payable in manner aforesaid then I direct the said monies and premises shall go to and be equally divided between and amongst all and every the children then living of my daughter Alice the late Wife of George Price of Warminster aforesaid Victualler I give unto my said Wife the use of all and singular my household goods and furniture and implements of housekeeping plate linen and china for and during the term of her natural life and after her decease I give and devise the same unto my said Son David Mead for his own use and benefit All the Rest and Residue of my Estate and Effects whatsoever and wheresoever and of what nature and kind soever I give and begueath unto my said Son David Mead his heirs executors administrators and assigns to and for his and their own use and benefit Subject nevertheless to the payment of all my just debts funeral expences and the expences of proving this my Will And I do hereby make nominate constitute and appoint my said Son David Mead sole Executor of this my Will In Witness whereof I the said Joshua Gerrard Mead the Testator have to this my last Will and Testament set my hand and seal this thirty first day of March in the Year of our Lord one thousand eight hundred and twenty eight J G Mead
