



CHURCH WARDENS

For the parish of St Mary the Virgin, Calstone Wellington

Names and dates obtained from Bishop's Transcripts (BT), Church Warden's Account Books (CW) 1717 - 1753 and 1727 - 1881, the Vestry Minute and Account Book (V) 1881-1958 and Mr Derick Eadon, (DE) Churchwarden. Not all Account Book entries name the Church Warden(s), so the period of time served may be longer than the dates shown.
