In the Name of God Amen I Ann Strong of Fisherton in the County of Wilts Single woman being weak in body but of sound & disposing mind memory and understanding praised be God for the same but mindful of my mortality do this 10<sup>th</sup> day of March in the year of our Lord 1828 make publish & declare this my last Will and Testament in manner and form following that is to say first I commend my Soul into the hands of Almighty God my Creator hoping for a remission of all my sins by the Merits & Mediation of my Saviour Jesus Christ & my will is that I be decently & privately buried in Saint Edmunds Church Yard City of New Sarum in the same Grave with my dear Sister Elizabeth Alexander who departed this life february 10<sup>th</sup> 1828 I desire to be buried without any funeral pomp and with as little expence as possible I give & bequeath unto my niece Sarah Strong my feather bed bolster & pillows and two silver table spoons I also give and bequeath unto my niece Martha Bungay two silver tea spoons I also give and bequeath to my nephew William Strong four silver tea spoons and I give & bequeath the remainder of my household goods and furniture and also my wearing apparel unto my nephew William Strong and my two nieces Martha Bungay and Alice Strong and I direct the division thereof to be made to them by Mr John Clark of New Sarum Grocer my Executor in equal value as near as may be according to his own judgement and I do hereby give unto him the said John Clark the sum of five pounds for the trouble he may have in executing this my Will and after all expences paid by him as Executor relating to my concerns I give and bequeath the whole of what money I may die possessed of in the hands of Mr Brown Currier Castle Street Salisbury and all my Stock in

the New four pr cents Bank of England and every other of my property unto my three nieces Sarah Strong now living in London Martha Bungay Wife of George Bungay living at Alderbury in the County of Wilts Alice Strong living at Shrewton in the County of Wilts and my nephew William Strong living at Chichester in the County of Sussex to be equally divided between them And my will is that in case any or either of them the said Sarah Strong Martha Bungay Alice Strong or my nephew William Strong shall happen to die before me then I give & bequeath the share of him her or them so dying unto the survivors or survivor of them but if my niece Martha Bungay or my nephew William Strong shall happen to die before me then I give their share to the husband of the said Martha Bungay and the wife of the said William Strong if they should be living or otherwise to there children at such times and for there use and in such sum or sums as my Executor shall think fit for there benefit And I make the said John Clark Executor of this my Will Witness my hand this 10<sup>th</sup> day of March 1828 The X of Ann Strong
