THE FORTHCOMING SHOW AT DEVIZES

The annual meeting of the members of this association was held in the Town Hall, Devizes, on Thursday afternoon, Mr Edward Colston, of Roundway Park, president of the association for 1888, in the chair. Woolcott, Savernake; Mr B. W. Crees, Etchilhampton; Mr O. Farmer; Mr James Welch, assistant secretary, Market Lavington, &c. Mr Walter Long M.P., wrote expressing regret at his inability to attend.

The Hon. Secretary (Mr Walter Bouverie) read the annual report of the Council, which shewed that the accounts for the year 1887, after paying all outgoings, left a debt balance of £184 14s. 2d., but this was partly covered by investments in Consols, made in previous years, upon which the Council had no deemed it expedient to trench. They called the attention of the members to the fact that the present account included the assistant secretary's salary for 1886 and 1887, it having been the habit, in previous years, to pay that salary after the 1st of January; so that it looked in comparison with previous years the accounts looked worse by £55 17s. 6d. than they should do. The outstanding subscriptions amounted to only £40 10s. 6d., being a smaller sum than in any previous year. The Council and accepted an invitation from the town of Devizes to hold the annual exhibition there during the present year, on the 14th and 15th of June. Mr Edward Colston had kindly consented to be president of the association for the ensuing year. Looking to the state of the finance, the Council had determined to reduce the prize list for the present year, not in the number of prizes given, but merely in the amounts, and they were confident that the meeting would in no way suffer in consequence. From the report of the consulting chemist it appeared that there had been a falling off in the number of samples sent for analysis, and the Council wished again to call the attention of members to the advantage derived from the services of the chemist and the extremely moderate fees charged for analyses. - Appended to the document was the report of the Hon. Secretary on last year's show at Swindon. In spite of the fine weather the attendance shewed a falling off as compared with previous years, the receipts at the gates being £242 15s. 10d., as compared with £378 10s. 2d. at Salisbury, and £368 6s. 9d. at Trowbridge. This falling off was much to be regretted, but other societies suffered in the same way, it being

accounted for by the other attractions of the jubilee year. The entries were in excess of previous years. The classes for Oxford down sheep (of which at Swindon there were only two pens) and cross-breds (no entry) would be abandoned. The classes for cattle were well filled and would remain the same for this year. In conclusion, the Hon. Secretary acknowledged the kindness and cordial support he received from the Local Committee at Swindon, and said the association was particularly indebted to Mr H. Kinneir, for the exertions he took to give the society a hearty welcome to Swindon, and to Mr W. H. Kinneir for his invaluable services as local secretary.

Several alterations which the Council recommended should be made in rules 2 and 3, dealing with the entrance fees and the conditions under which entries could be made, were adopted, as also an additional rule having relation to the exhibition of implements. Rules 2 and 3 now read:-

- 2.- Entry fees shall be paid to the Assistant-Secretary at the time of entry, and shall be as follow:- For cattle, sheep, and pigs, 10s. for each entry; butter or cheese, 5s. each entry, horses, £1 1s. each entry. Members subscribing £1 annually shall have one entry free for butter and cheese, or one entry in the horse classes for 10s. 6d., or one entry for either cattle, pigs of sheep for 5s., provided such subscription has been received by the Secretary on or before the time of entry.
- 3.- No horse or other animal can be entered in two classes, except in the case if special prizes, but an exhibitor can have an unlimited number of entries in any class.

ANNUAL SHOW AT DEVIZES

As we go to press, the two days annual exhibition in connection with the County Agricultural Association is being held in Devizes, and has proved to be, on the whole, the largest and most important yet held under its auspices. Indeed, the extent to which the exhibition has grown during the comparatively short time since it was inaugurated bears eloquent testimony to the foresight and sound judgment of those who established it, as well as to the tact and discretion which have characterized its management. Formed at an influential meeting of agriculturalists, held at Trowbridge on January 7th, 1885, the County Agricultural Society practically grew out of the old Marlborough and Pewsey Vale Association, which, having done good work in the course of its existence, had practically outgrown the resources of the district which gave it birth. But though young in years the county show has been from the first fortunate in securing the sympathy and practical help of agriculturalists who had had many years of experience in the management of local shows, and its record, from the inaugural show at Trowbridge in the year 1885 to the present time, has been one of useful work and steady progress. The first exhibition at Trowbridge assumed such dimensions as to at once place beyond doubt the success and popularity of the Association, and of only a sufficient amount of pecuniary support can be secured, the association seems destined to enjoy a long period of useful activity which cannot fail to exert a beneficial influence upon the agriculture of the county generally. In the second year of its existence the city of Salisbury gave the society a very cordial welcome, and the show reached its maximum in the matter of attendance. The exhibition at Swindon last year was in some respects the best which had up to that time been held, but the counter attractions of the then impending jubilee celebrations were not without an injurious effect upon the exhibition form a financial point of view; as, indeed they similarly affected every other gathering of a similar character. When it was intimated that the Society was prepared to honor Devizes with a visit, the project was cordially taken up by the Mayor (Mr T. Chandler) and the inhabitants generally. Our genial and public-spirited neighbor, Mr Edward Colston (who was chosen President of the Society for the year), and the present Mayor of the borough (Mr J. F. Humby) supported the movement with characteristic energy; a local committee of practical men - in the persons of the Mayor and Messrs F. Reynolds,

B. Crees, J.A. Randell, W. H. Burt, G. Simpson jun., E. Coward, and G.S.A. Waylen – was appointed, with Mr F. Sloper, the well-known auctioneer, as hon. secretary, to assist the general committee in carrying out the arrangements; and so well did the inhabitants of the town and neighbourhood respond to the appeal made to them for subscriptions towards the expenses of the meeting, that the Society were enabled to offer a prize-list in every way creditable to the county, and sufficient to attract one of the largest shows that has yet been held under its auspices. In all, about £315 was raised as the local fund. Indeed, the liberality shewn by the people of the town and district in a time of great agricultural and trade depression speaks volumes for the interest taken in the Society in this immediate neighbourhood, and proves that all interested in the trade of Devizes fully recognize the close relationship which the prosperity of agriculture bears to the success of business enterprise. It is interesting at this point to recall the fact that it was the great success which attended the show of the old Marlborough and Pewsey Vale Association held in Devizes in the year 1879 which first brought into prominence the fact, that if the exhibition in its enlarged dimensions was to be successfully carried into the future, it would be necessary at no very distant date to merge it into a county show; and it is with no small amount of satisfaction that we are able to look back and point to the show which led up to the formation of the County Association having been held in Devizes, and at a later period to what, taken as a whole, is the most important show which has been held under the auspices of the county society. We trust that the result of this show will be to give a much-need stimulus alike to agricultural pursuits, and to the trade of the town in which the gathering is held.

A NEW DEPARTURE

A meeting of the Council was held at the Ailesbury Arms Hotel, Marlborough, on Saturday last, the 15th inst. There were present the hon. secretary, Mr Walter Bouverie (chairman), Mr E. B. Merriman, hon. treasurer, and Messrs E. Burbidge (South Wraxall), W. D. Butler (Rowde), J. Carpenter (Burcombe), G. Chapman (Radley), I. Clark (Heddington), W. H. Dunn (Templeton), G. Ferris (Milton), W. H. Godding (Brimslade), E. H. Green (West Lavington), B. Hayward (Manton), Mark Jeans (Marlborough), F. R. Moore (Littlecott), T. N. Redman (Upton Lovell), W. J. Rowden (Upavon), F. Sloper (Devizes), T. Sisum (Ogbourne St. George), S. W. Tayler (All Cannings), H. Woolcott (Savernake) and J. Welch, secretary (Market Lavington) – Some additions and alterations were made to the prize schedule, and the names of proposed judges for the various departments were selected. Mr George Ferris then proposed a resolution of which he had previously given notice by circular, "that a local auctioneer be annually appointed by the Council to hold a sale in the show-yard on the second day; that he charge a commission of 5 per cent., including all his expenses of advertising, &c., for which privilege he shall return to the Society one-third of such commission." He suggested that the sale should take place in the ring

opposite the Grand Stand. By this the funds of the Society would be very much increased by gate money, takings at the Grand Stand and the commission named. He said that he had receive replies from seven or eight members of the Council who were unable to be present, warmly supporting his proposal, and also from several farmers, who considered the arrangement would be a great boon, and promised to make entries.-The Council, after many expressions of approval unanimously passed the resolution. It was also decided that to prevent inferior animals being entered expressly for sale, that with the exception of yearlings and two-year-olds, no animal should be put up at less than 50 guineas, owners being allowed to fix any higher reserve they may choose, and various changed have been made for the benefit of tenant farmers. Extra classes will also be introduced – amongst them a prize, the gift of Mr George Ferris (Milton), for a single carthorse, also for five whether lambs and five ewes, the property of tenant farmers who do not sell rams by auction, the gift of J. G. Eagles (Leamington).- The appointment of an auctioneer was then proceeded with, after the three auctioneers present had withdrawn, with the result that Mr Mark Jeans, of Marlborough, was unanimously chosen to fill the office for the forthcoming show.- A meeting of the Executive Committee was afterwards held, and stewards were selected, and other business transacted.- The Society is likely to be well supported in Marlborough, and a good show is expected, the days fixed being the 17th and 18th of June.

THE ANNUAL SHOW

The sixth annual show in connection with the Wiltshire Agricultural Association was held on Tuesday and Wednesday, at Marlborough, and proved to be in nearly every respect one of the most successful the Association has ever held. Started originally in 1885 with the old Marlborough and Pewsey Vale Society as a nucleus, the Wiltshire Agricultural Association was designed to embrace the whole of the county of Wilts. Its promoters, and those who have since joined its Council, have worked hard to achieve the object with which it was started, and while they have not attained the goal of their ambition, they have accomplished much that is creditable to them, and which fully justifies their existence and their claim to public support. It would be difficult, almost impossible, to gauge with any accuracy the amount of good which has been done by the Association's efforts to improve the breed of farm animals, and to promote and encourage a more scientific system of farming and a broader and clearer view of agricultural economy that has hitherto prevailed. There are a few occupations which require greater fore-thought and care than farming, more especially in these days of world-wide competition, and yet it would hardly be an exaggeration to say that in years past there was scarcely any calling in which men were more guided by rule of thumb and mere chance and haphazard than that of husbandry. The vast improvement that has taken place within the last decade or so is in great measure owing to the efforts of such associations as that which held its annual competition at Marlborough this week. Careful breeding and scientific cultivation are now essentials to success in farming pursuits. The high perfection to which cattle and Hampshire Down sheep have been brought are evidences of skillful breeding and care in the selection of parents, and the same skill and care is fostered and furthered all over the county by such societies as the Wiltshire Agricultural Association. All, therefore, who have at heart the welfare of that industry which is the industry of all races and of all times, should support the efforts of such societies.

With regard to the show itself it is pleasant to be able to record that it has been one of the best ever held by the Society. The weather on Monday was particularly fine and enabled those in charge of the arrangements to proceed with them very rapidly. Heavy showers fell early on Tuesday morning, but from six o'clock the weather was fine and remained so until late afternoon, when rain again fell heavily
